



## PRIVACY POLICY

This Privacy Policy describes how **Evoltex LTD** collects, processes, stores, and protects personal data of users who visit the website **evoltex.org** or use the Company's trading services.

By accessing the website or using the services of the Company, you agree to the terms of this Privacy Policy.

## 1. INTRODUCTION

## 2. INFORMATION WE COLLECT

The Company may collect several types of information from Clients and website visitors.

### 2.1 Personal Information

Personal information may include:

- date of birth
- residential address
- email address
- telephone number
- identification documents
- nationality and country of residence

Personal information is collected during:

- account registration
- identity verification (KYC)
- communication with support services
- participation in promotions or services offered by the Company.

Clients may request corrections or updates to their personal information at any time.

## 2.2 Financial Information

Financial information may include:

- bank account details
- payment card details
- transaction history
- deposit and withdrawal records.

Financial information is necessary for the proper operation of trading accounts and for processing payments between the Client and **Evoltex LTD**.

Such information may be shared with trusted third parties including:

- payment service providers
- banks
- electronic payment systems
- financial institutions involved in transaction processing.

These third parties are required to maintain confidentiality and data security.

## 2.3 Website Usage Data

The Company may collect technical data when users visit **evoltex.org**, including:

- IP address
- browser type
- device type
- operating system
- pages visited
- session duration.

This information is collected automatically through:

- cookies
- analytics tools
- server logs.

The purpose of collecting such data is to:

- improve website performance
  - analyze traffic statistics
  - enhance user experience
  - maintain website security.

### 3. USE OF COOKIES

Cookies are small data files stored on a user's device when visiting a website.

Cookies may be used to:

- remember user preferences
- improve website functionality
- analyze website usage
- enhance security.

Users may disable cookies through their browser settings, although some website features may not function properly without them.

### 4. STORAGE AND TRANSFER OF DATA

Personal data collected by **Evoltex LTD** may be stored and processed on secure servers.

Client information may be transferred to:



- affiliated companies
- service providers
- payment processors
- regulatory or legal authorities when required by law.

All such transfers are performed in accordance with applicable data protection regulations.

Clients are responsible for ensuring that the information they provide is accurate and up to date.

The Company reserves the right to request additional documentation to verify the accuracy of provided information.

## 5. DATA SECURITY

The Company takes appropriate technical and organizational measures to protect Client information against unauthorized access, loss, misuse, or disclosure.

Security measures include:

- encrypted communications (SSL encryption)
- secure servers
- restricted access to personal data
- internal security procedures.

Despite these precautions, no system can guarantee absolute security.

Clients are responsible for maintaining the confidentiality of their account credentials and passwords.

## 6. DISCLOSURE OF INFORMATION

The Company does not sell, rent, or distribute Client personal information to third parties except in the following cases:

- when required by law or regulatory authorities
- to payment service providers and financial institutions
- to service providers assisting the Company in delivering services



- to prevent fraud, money laundering, or illegal activities.

Information may also be disclosed if necessary to protect the rights, property, or safety of the Company, its Clients, or third parties.

## 7. CLIENT RESPONSIBILITIES

Clients are responsible for:

- maintaining the confidentiality of login credentials
- providing accurate and truthful information
- promptly notifying the Company of any unauthorized access to their accounts.

The Company shall not be responsible for losses resulting from the Client's negligence in protecting account information.

---

## 8. CLIENT RIGHTS

In accordance with applicable data protection laws, Clients may have the right to:

- request access to their personal data
- request correction of inaccurate information
- request deletion of personal data (where legally permissible)
- restrict or object to data processing
- request data portability.
